This one is special because the nubs of the ruled lines are removed before the Logo and type are overlaid.  
Here the nubs have been removed by trimming or cropping the horizontal ruled lines on the left  
The right side appears trimmed as well.

I placed red vertical lines to show how straight the trimming/cropping turned out as well as how the printed left margin changes from the top 13-14 horizontal ruled lines on the image to the bottom 8-9 horizontal ruled lines on the image.

I placed Red Horizontal Lines to show how crooked the bottom 8-9 horizontal ruled lines look compared to the top 13-14 horizontal ruled lines.



Even with the nubs of the ruled lines removed and the sides trimmed straighter,  
this is still obviously one paper laid over the top of another.  
WHY?
