I know you are busy with other things and maybe I am only disturbing you but with the Supreme Court deadline date only 5 days away and naturally I am a bit worried.

It would ease my mind if I had some idea of when you will begin discussing this with me.

Please provide a date and time that I can set aside so we can begin discussing the appeal to the Supreme Court from the 2nd Appellate District case 2-23-0072.

Thank you and I am sorry if I seem to be pestering you, I understand you are busy.

In the meanwhile I have been getting things done. Hopefully I should have the judicial complaints against Berg (for recusal issues in 17LA377) and the three appellate court judges (for hiding their names not allowing us to do a conflict check or ask for a substitution of judge till their final ORDER) by tomorrow submitted to the Supreme Courts Judicial Inquiry Board.

Also, I made another trip to the Clerks office yesterday and purchased parts of 11DV324 (Kim Popovich vs Tom Popovich Dissolution of Marriage).

I purchased both the Petition for Dissolution of Marriage (Kim Popovich claims she is not only an owner of the law offices of Thomas J. Popovich, P.C. but one of its founders) and the JUDGMENT OF DISSOLUTION OF MARRIAGE (large parts missing due to a court ORDER sealing much of its contents).

I also purchased all court orders from the cases inception (5/4/2011) to the day of the dissolution (3/11/2013).

Unfortunately due to the sealed records I don't believe I can say definitively wether Kim Popovich did or did not own shares in the law offices of Thomas J. Popovich, P.C. after 3/11/2013.

One thing for sure though is Kim Popovich did own shares during the time the law offices of Thomas J. Popovich, P.C. represented me and the dissolution of marriage happened between the Gagnon and McGuires depositions making her a liable party for the fraud committed before 3/11/2013.
